RULES

Art. 1 – Painters, sculpturers, graphics, photographers can participate to the Biennial Exhibition divided into 3 sections

- A) Artists selected through regional or foreign exhibitions
- B) Professional Artists, marked by Commission
- C) Professional Artists, of clear fame, on CIAC invitation

Art. 2 – Either Italian or foreign artists can participate

Art. 3 – Biennial exhibition will be set in Rome from 21th to 30th January 2012 in prestigious “Sale del Bramante” (P.zza del Popolo) where exhibition by **Picasso, Chagall, Mirò, Goya** and **Dali** have been set in the past.

Art. 4 – To Biennial Exhibitions can participate: arrive

- 1) Artists (sec. A) introduced by giury, formed by **Galleries, Cultural Centres, Academies, Embassies**
- 2) Professional artists (sec. B) selected by Biennial Exhibition Commission on the basis of the artists’ curriculum, after a careful check of all documentation of artistic productions.
- 3) Professional Artists (sec. C) of clear national or international fame on invitation of CIAC direction.

Art. 5 – Application form and all documents have to be given within 30th September 2011.

Art. 6 – All selected artists of section A and B, will be required 2012 CIAC registration, as associate supporter. Booking rate, € 400, will be accepted through C/C N. 18348003 postal money order or bank check and it will have to be received by CIAC Direction Via dei Mille 40 – 00185 Rome within 10th November 2011. Payments from Italy will have to reach CIAC (Centro Internazionale Artisti Contemporanei) Direction through banking transfer addressed to Intesa/San Paolo agency n. 10 - Via Ciamarra, 234 - 00173 Roma. (ABI 03069 – CAB 05058 - conto 201/53). From abroad it is necessary to specify: IBAN IT11 M030 6905 0580 0000 0020 153 BIC BCITITMM729.

Biennial Exhibition Direction is not responsible for postal delays of required documentation or for booking rate delays. Selected artists have to send documentation through e-mail quoted on Exhibition Rules which will be communicated to all interested people.

Art. 7 – Biennial Exhibition will expose one work (painting, sculpture and photo) with given dimensions. The selected works must be max 100x150 for paintings, max 50x50x150 for sculptures and 50x70 for photos. Bigger works could be accepted by Biennial Exhibition Commission. Selected works will have to be framed simply and not by flamboyant frames. Works will have to reach CIAC technical office, Mail Boxes 089 – via dei Mille,40 – 00185 Roma within 20th December 2011. Particular conditions will be allowed to artists for transport and insurance of the works both on their receipt and their return. These particular conditions will be stated in the Exhibition Rules or will be there enclosed.

Art. 8 – During the exhibition CIAC Direction will give to all expositors the Biennial Exhibition Catalogue. The catalogue, written also by famous art critics, will have one colour page for each artist.

Art. 9 – Biennial Exhibition Commission during the exhibition will state winners who will show their works in a free exhibition (insurance and despatching expenses not included) in elegant places in Perugia or other town. The final results are unappealable.

Art. 10 – CIAC Direction will distribute a brochure. Public and private TV, national and international press will be informed and a live show will take place on Internet.

Art. 11 – Public and private representatives, Embassies and national and international Academies and Art and Culture representatives will be invited to the Biennial Exhibition.

Art. 12 – Dates, rules and places can change.
